THIS PROGRAM INCLUDES CHAPEL, HIGH-COMMITMENT SHELTER, EMERGENCY SHELTER AND MEAL MINISTRY WITH COMMUNITY OUTREACH. THE HIGH COMMITMENT SHELTER IS FOR A MAN WHO COMMITS TO 90 DAYS OF CASE MANAGEMENT. THIS ALSO INCLUDES CONNECTIONS TO EMPLOYMENT, MEDICAL SERVICES, HOUSING AND OTHER SERVICES. IN RETURN, HE WILL RECEIVE SLEEPING QUARTERS AND A PRIVATE STORAGE AREA FOR HIS BELONGINGS.
